

The measures are being issued in accordance with the decision of 129th Session of the *Lhengye Zhungtshog* held on 14th September 2022, with immediate effect. The Ministry of Agriculture and Forests in collaboration with the Regulatory Authority, *Dzongkhag*, *Thromdes* and other stakeholders are required to implement the measures being introduced today.

Annexure 1: ADDITIONAL LIVESTOCK AND PET MANAGEMENT MEASURES

Managing feral, aggressive and stray animals

1. The Ministry of Agriculture and Forests shall prescribe necessary measures for the management of feral, aggressive and stray animals to safeguard public health and safety.

Proper care of pet animals

2. The owner shall take proper care of the pet animals. Any person who abandons the pets shall be liable for payment of fines prescribed in the Livestock Rules and Regulations. The animal shall then be confiscated.
3. Owners who release or fail to secure the pets in public places shall be liable for payment of fines prescribed in the Livestock Rules and Regulations. The owner shall also be liable for payment of medical costs, labour days lost, or production loss in case of injury to animal or cost of property damaged.

Management of animal shelters

4. The Animal Welfare Organisations, *tshethar tshogpa* or any other entity or person desiring to establish and operate animal shelters shall obtain technical clearance from the Department of Livestock. Failing to do so shall be liable for payment of fines prescribed in the Livestock Rules and Regulations, and will also result in closure of animal shelter and confiscation of animals.
5. The management or release of animals by the Animal Welfare Organisation, *tshethar tshogpa* or any other entity or person shall be regulated as per the Bhutan Animal Welfare Standards and Guidelines, and *Tshethar* Guidelines prescribed by the Ministry of Agriculture and Forests. Any release of animals in contravention to prescribed standards and guidelines shall be liable for payment of fines prescribed in the Livestock Rules and Regulations.

Prohibition on the feeding of stray animals

6. The feeding of stray animals in public places, highways or roadsides shall be prohibited to safeguard public health and safety. Any person or agency who feeds stray animals in contravention to this provision shall be liable for payment of fines prescribed in the Livestock Rules and Regulations.

Enforcement

7. The Ministry of Agriculture and Forests, Regulatory Authority and the concerned Local Authorities shall enforce the additional livestock and pet management and regulatory provisions.
