1. You are invited to submit your priced bid for the supply of the following items :
Excavator hiring for landscape development
2. The bidder(s) must quote for all items under this invitation¹. Each item shall be evaluated and the contract will be awarded to the firm offering the lowest evaluated price (sum of all the prices)
3. The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked ORIGINAL. In addition, the bidder shall submit a copy of bid, marked "COPY". The quotation including all documents should be sealed in an envelope as required by PRR 2019 clause 5.1.7.2.in the event of any discrepancy between original and copy, the original shall prevail. Your quotation in the required format should be addressed and submitted to:

4. The deadline for receipt of your quotation(s) by the purchaser at the indicated address is **latest by 10:00AM on 1st April 2022** and will be opened on the same day by 10:30AM in DYT hall/conference hall.
5. Quotation by fax **is not** acceptable.
6. The quotation should be submitted as per the following instructions and in accordance with the attached Contract. **The attached Terms and Conditions of Supply is an integral part of the Contract.**
 - a) PRICE: all prices shall be quoted in Ngultrum. (Bhutanese currency) The quoted price shall be inclusive of all related costs including taxes, duties and other levies to the final place of delivery. **The final place of delivery is as per work order.**
 - b) EVALUATION OF QUOTATION: offers determined to be substantially responsive to the technical specifications will be evaluated by comparison of their quoted prices. In evaluating the quotations, the purchaser will determine for each quotation the evaluated price by adjusting the priced quotation by making any correction for any arithmetical errors as follows;
 - (i) Where there is a discrepancy between amounts in figures and in words, the amount in words will govern;
 - (ii) where there is discrepancy between the unit rate and the line item total resulting from multiplying the unit rate by the quantity, the unit rate as quoted shall govern unless in the opinion of the Employer there is an obviously gross misplacement of the decimal point in the unit rate, in which case the line item total as quoted shall govern, and the unit rate shall be corrected.
 - (iii) if the supplier refuses to accept the correction, this quotation will be rejected and the bid security shall be forfeited.
 - c) AWARD OF PURCHASE ORDER: the award will be made to the bidder who is offering the lowest sum of evaluated price. The successful bidder will sign a contract as per attached form of contract and terms and conditions of supply.
 - d) VALIDITY OF THE OFFERS: your quotation(s) shall be valid for a period of 30days (1month) from the deadline for receipt of quotation(s).

7. Further information can be obtained from Dzongkhag Agricultural and Dzongkhag Procurement section on any working days.
8. The quotation(s) will be opened in the presence of bidders or their representatives who choose to attend at the specified venue and time.
9. The Evaluation shall be done within 5 working days from the date on opening by Evaluation Committee.
10. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
11. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period.

The terms of the accepted offer shall be incorporated as follows:

A) Qualification criteria

- I) The contract period is valid for 1 year from the date of award of contract
- II) Should have valid vehicle registration certificate issued by RSTA office
- III) Should deploy experienced driver

B) Requirement Conditions

- i) Quoted rate shall remain same for the entire contract period
- ii) No idle charges shall be made for breakdown of machine. It shall be the sole responsibility of the vehicle owner.
- iii) Expenditure incurred for the maintenance of the vehicle shall be under taken by the owner at their cost.
- iv) Should qualify all the requirements set by RSTA pertaining to compliance and other road safety measures

C) Other terms

- i) The Dzongkhag tender committee reserves the right to reject if the service and other compliances is found unsatisfactory and forfeit the performance security.
- ii) The winning party is not allowed to sublet the providing of services to third party.

12. The successful bidder has to deposit A sum of **Nu 40,000/- (Ng. Forty thousand)** only in the form of cash warrant, demand draft or unconditional Bank Guarantee issued by a financial institution located in Bhutan, which shall be submitted before signing the contract. Performance security shall be valid till the end of warranty period and will be returned after the end of warranty period after adjustment of dues if any.
13. The Purchaser may, by written notice, terminate the contract term at any time for its convenience:
 - a. If the Supplier fails to perform any other Terms and conditions specified with the work Order or if the bidder fails to perform any other obligation(s) under the supply Order, or
 - b. If the Supplier, in the judgment of the Purchaser (Dzongkhag Administration), has engaged in any corrupt or fraudulent practices in competing for or in executing the tasks under this supply Order

. Award of Contract

1. The Purchaser will determine to its satisfaction whether the bidder selected as having submitted the lowest evaluated, responsive bid; per package basis is qualified to perform the Contract satisfactorily.
2. The determination will take in account the bidders financial, and manpower. It will be based upon an examination of the documentary evidence of the bidders qualification submitted by the bidder.
3. An affirmative determination shall be a prerequisite for award of the Contract to the Bidder. A negative determination will result in rejection of the bidder's Bid.
4. The Purchaser will award the Contract to the Bidder whose bid has been determined to be the lowest evaluated responsive Bid.

- 3. This Contract shall prevail over all other Contract documents. In the event of any discrepancy or inconsistency within the Contract documents, then the documents shall prevail in the order listed above.
